Special Recognition:

Murray City Employee of the Month – Julie Debban - Building Division Office Administrator. Mayor Hales expressed appreciation to Ms. Debban. Adam Hock presented the certificate and \$50 gift card and Phil Markham and Thomas Butz commended her for all of her hard work in the Building Division.

Citizen Comments:

Lacey Parker – Murray Resident

Ms. Parker said she recently learned about light pollution which can be reduced by shining street lights in a downward position. She asked the Council to learn about light pollution noting that the outdoor lighting at City Hall currently points upward at trees.

Public Hearings:

An ordinance amending the Zone Map from R-1-8 (Low Density Single Family) to R-2-10 (Medium Density Residential) for the property located at 1151 East 6600 South. Planning Manager Zac Smallwood said Kenneth and Jean Kitt requested the Zone Map amendment. An aerial map was shown to verify that the request to build a townhome complies with the requirements of the R-2-10 Zone and the Future Land Use Map. Mr. Smallwood compared the zoning regulations of the R-1-8 to those of the R-2-10 and outlined the allowed land uses of each zone. He reviewed the findings to explain why the Murray Planning Commission voted 7-0 on May 2, 2024 in favor of recommending approval to the City Council and noted that staff supported the request

also.

The public hearing was open for public comments. No public comments were given, and the public hearing was closed.

Consider an ordinance amending the General Plan to adopt the Murray North Station Area Plan. Planning Manager Zac Smallwood said planning staff requested the adoption of the Murray NSAP (North Station Area Plan) that covers an area in Fireclay near Interstate 15 to State Street, and from Center Street in Millcreek City to Miller Street in Murray. Utah State House Bill 462 requires cities with fixed rail stations to complete affordable housing plans within a half-mile radius from all Front Runner and TRAX station platforms and Bus Rapid Transit infrastructure. The deadline is December 31, 2025 for cities to adopt station area plans so two more plans will be presented to the Council within the next year and a half.

Mr. Smallwood shared the NSAP vision, discussed existing conditions of the area and reviewed elements of the plan involving improvements to quality of life, safety, land use, connectivity, livability and urban design. He said the biggest challenge in Fireclay was the very low per capita income where finances are spent mainly on housing, transportation and everyday living costs, allowing no room for disposable income spending. He discussed existing retail vacancies in Fireclay saying retailers do not want to move there because they understood the demographic and the lack of high spendable income.

Ms. Dominguez thought the City could introduce incentive programs, such as subsidized rent or utility expenses to attract retailers to existing commercial spaces at Fireclay. Mr. Smallwood agreed State funding opportunities are available through the RDA (Redevelopment Agency) but recent changes were made to how RDA funding can be offered to retailers. Ms. Dominguez argued that Millcreek was doing a successful job in getting retail businesses on their side of the Fireclay area with incentives.

Mr. Smallwood said to bump up higher spending in Fireclay, a higher market rate of housing is needed even though the NSAP calls for affordable housing. Also needed is stewardship, which is to clean up vegetation and garbage; crime prevention through environmental design; and ways to create civic pride. He discussed long-term changes that would take years, regarding land use and connectivity and solutions to changing the narrative of Fireclay. He said the Planning Commission forwarded a positive recommendation of approval to the City Council on April 4, 2024 that planning staff also supported. Millcreek City already adopted the plan, so any changes made by the Murray Council would go back to them for approval.

The public hearing was open for public comments:

Peter Klinge – Murray Resident

Mr. Klinge wondered what percentage of new affordable housing properties would be rentals, and asked if existing Fireclay apartments were fully occupied. He asked what retail services were currently offered and if those businesses were meeting the income threshold as far as retailers were concerned. He questioned how was it that retailers were not meeting the consumer demand when residents in the area need groceries and other items. He questioned why retailers do not want to locate there and why these services could not be

provided. He did not believe it made sense to subsidize new stores to the area if nobody wanted to shop them.

Madeline West – Murray Resident

Ms. West said as residents of Birkhill Apartments she and her husband who live at the center of the NSAP came to urge Council Members to approve the plan. They supported the initiative and were very excited to see some parks in the area and a connection to the Jordan River Trail.

The public hearing was closed.

Mr. Smallwood said there is a great amount of rental housing in Fireclay, but there are also some properties available for sale. A map was shared to show existing rental units, condominiums and proposed housing areas identified at the foam factory property and larger properties owned by Utah Transit Authority and Salt Lake County. He said it would be tricky to demand market rate housing where identified properties are not for sale. Getting a grocery store to locate inside Fireclay was not feasible, so the suggested site is at 4500 South and Main Street to attract local visitors.

ORDINANCE NO. 24-

AN ORDINANCE ADOPTING THE RATE OF TAX LEVIES FOR THE
FISCAL YEAR COMMENCING JULY 1, 2024, AND ENDING JUNE 30,
2025.

PREAMBLE

UTAH CODE ANN. Title 59, Chapter 2 states that each year, the governing body of each city shall, by ordinance or resolution, adopt final tax levies for its General and Library Funds. The proposed total tax rates exceed the certified tax rate. UTAH CODE ANN. Title 59, Chapter 2 provides for certain notice and hearing requirements if the proposed total tax rates exceed the certified tax rate.

Pursuant to UTAH CODE ANN. Title 59, Chapter 2 the Council caused to be published a notice stating that the Council would have a public hearing on August 13, 2024, at 6:30 p.m. in the Murray City Council Chambers, 10 East 4800 South, Murray, Utah to receive public comment on the proposed tax levies for its General Fund and Library Fund which would exceed the certified tax rate. The notice was published in the Salt Lake Tribune and the Deseret News once each week for two weeks preceding August 13, 2024. The August 13, 2024, public hearing was not less than seven (7) days after the first publication. The notice was also published on the Utah Public Notice website and the Public Legal Notice website, as required by law. The notice was also published on the City's website and posted at city hall.

On August 13, 2024, pursuant to the notice, the Council held a public hearing to receive public comment regarding the tax levy in the General Fund and the tax levy in the Library Fund. The Murray City Municipal Council wants to adopt final levies for fiscal year 2024-2025 subject to the requirements of UTAH CODE ANN. Title 59, Chapter 2.

BE IT ENACTED by the Murray City Municipal Council as follows:

Section 1. Purpose. The purpose of this Ordinance is to adopt the tax levies for fiscal year 2024-2025 having complied with the requirements of UTAH CODE ANN. Title 59, Chapter 2.

Section 2. Enactment.

1. The Murray City Municipal Council hereby levies, upon property within the City, made taxable by law in the year 2024 for the fiscal year of the City ending June 30, 2025, a tax of .001483 on each dollar of taxable valuation of said property as revenue in the General Fund and a tax of .000309 on each dollar of taxable valuation of said property as revenue in the Library Fund for a combined total tax of .001792 on each dollar of taxable valuation of said property.

2. The Murray City Municipal Council hereby further levies a tax to cover the costs of mandates by the Utah State Legislature or judicial or administrative orders under UTAH CODE ANN. Title 59, Chapter 2 as determined by the Utah State Tax Commission and the Salt Lake County Auditor.

3. The tax levies herein above determined and levied shall be certified by the City Recorder to the Salt Lake County Auditor pursuant to the provisions of UTAH CODE ANN. Title 59, Chapter 2.

4. The City hereby expressly reserves the power and right to amend any tax levy made herein as it may deem just and appropriate under the law.

Section 3. Effective Date. This Ordinance shall take effect immediately on its passage.

Tax Rate Increase Advertisement Requirements

Instructions for newspaper publication:

- The advertisement shall be no less than 1/4 page in size
- The type used shall be no less than 18 point
- A 1/4 inch border shall surround the advertisement
- The advertisement may not be placed in that portion of the newspaper where legal notices and classified advertisements appear

Instructions for the taxing entity:

- The advertisement shall be published in:
 - 1) a newspaper or combination of newspapers of general circulation in the taxing entity
 - 2) Electronically in accordance with Section 41-1-101: on a website established by the collective efforts of Utah newspapers www.utahlegals.com
 - 3) On the Utah Public Notice Website created in Section 63F-1-701 www.utah.gov/pmn/index.html
- It is the legislative intent that whenever possible the advertisement should appear in a newspaper that is published at least one day per week
- The newspaper or combination of newspapers selected shall be of general interest and readership in the taxing entity and not of limited subject matter
- The advertisement shall run once each week for two weeks preceding the hearing.
- If the taxing entity is in a county that is required to publish a list (59-2-919.2), the taxing entity is only required to published one advertisement, one week before the public hearing
- The advertisement shall state that the taxing entity will meet on a certain day, time, and place fixed in the advertisement. The exact wording for the advertisement can be found in 59-2-919
- The scheduled hearing shall not be held less than ten (10) days after the mailing of the "Notice of Property Valuation and Tax Change" by the county auditor
- The scheduled meeting on the proposed tax increase may coincide with the hearing on the proposed budget
- The scheduled meeting shall begin at or after 6:00 P.M.


How are property tax rates determined?

The State of Utah, in order to safeguard property owners from paying increased property tax when all property values are increasing, implemented a law known as Truth in Taxation (TNT). This law guarantees the City the same property tax revenue plus new growth each year. The City may request new revenue by going through Truth in Taxation which includes a public hearing.

Murray has held Truth in Taxation in 2018, 2022, 2023, and 2024. The 2024 rate without the revenue increase would be .001413.



In FY2019 there was a 46% tax increase. Murray Citizens requested the City do smaller more frequent property tax increases. A 4.95% property tax increase is proposed for FY2025. For the average residence with a value of \$565,000 the increase will be \$21.75 per year. A 3.2% increase was requested FY24, and 15% in FY23. These three increases are the only ones since FY2019. The small revenue increases seen in the graph are due to new growth.

How much of your property tax dollar goes to Murray City?

For the tax year 2023 and depending on where you live it was:



Depending on where you live within Murray City for every dollar you pay in property taxes, the City of Murray receives 18 cents or 14 cents. Funds received from property tax paid by residents and commercial property owners cover about 19% of the 2025 proposed budget.

A property tax increase has not been proposed for the Murray City Library. All residents of Salt Lake County pay either their city's library property tax (.000309) or the county's library property tax (.000477).

Unlike commercial property owners who pay taxes on the full value of their property, residents get a discount and only pay taxes on 55% of their property value.


All cities have different property tax rates based on need. For FY2024 Murray City had the 9th highest out of 17 taxing entities. If all the other cities proposed property tax increases pass, and the county library property tax increase passes, Murray's City and Library combined property tax rate will be 12th highest.

Why a Property Tax Increase?


The property tax increase will cover the cost of adding 1 new police officer, 3 paramedic/firefighters, and a fire inspector, along with other costs which have increased due to inflation.

The City maintains a balanced budget so any increases in facilities, personnel or services requires increased revenue, or discontinuing other programs and services.

BESIDES NORMAL OPERATIONS WHAT DOES THE BUDGET CONTAIN?

A few of the Capital Improvement Projects Fund's approved projects include:

- \$126,000 for Police cars & equipment
- \$939,743 for Fire equipment including a new ambulance
- \$640,000 for projects needed at Woodstock & Willow Pond parks.
- \$2,175,000 to purchase property along the Jordan River for park or open space.
- \$1,908,000 in street overlays, rebuilds, traffic signal upgrades, and radar speed signs.
- \$500,000 to purchase a small lot in Fireclay area for a small park or open space.

The Murray City enterprise funds (Water, Wastewater, Power, Stormwater, and Solid Waste) continue to invest in their systems as outlined in their master plans.

Truth in Taxation Public Hearing

August 13, 2024

What is Truth in Taxation

- ▶ Truth in Taxation is the common term used for Utah's property tax system
- ▶ The statute was passed in 1985
- ▶ It is designed to prevent property taxes from increasing just because property values are increasing.
- ▶ Cities are guaranteed the same property tax revenue plus new growth each year
- ▶ The mill levy adjusts down as property values increase
- ▶ There is a process outlined if a City want to increase the revenue it receives.

A Property tax increase is needed because?

- ▶ When property values increase the tax rate is adjusted down UNLESS the City requests a property tax increase. The City is guaranteed the same amount of Property tax dollars + new growth every year.
- ▶ The increased revenue will cover the cost of adding 1 new police officer, 3 paramedic/firefighters, and a fire inspector along with covering other costs which have risen due to inflation.
- ▶ In 2018 (a property tax increase of 45%) the city was asked to do more frequent and smaller increases. A 15% increase was approved in 2022, 3.22% in 2023. This request is 4.95%

How Much is the increase?

- ▶ The new revenue is a 4.95% increase for the City tax or \$583,777. No increase was requested for the Library Tax.
- ▶ For the average city residence assessed at \$565,000 the tax increase will be \$21.75 per year or \$1.81 per month
- ▶ For a commercial property valued at \$565,000 the tax increase will be \$39.55 per year or \$3.29 per month
- ▶ The amount of increase you may experience will vary based on how your property value increased in comparison with other areas or property types within the City.

ORDINANCE NO. 24 -

AN ORDINANCE ADOPTING THE FINAL 2024-2025 FISCAL YEAR BUDGETS FOR MURRAY CITY INCLUDING THE LIBRARY FUND BUDGET.

PREAMBLE

Section 10-6-118 of Utah Code, as amended, requires adoption of the City's final budgets before June 30th of each year. Tentative budgets approved by the Murray City Municipal Council have been open for public inspection since April 16, 2024, as required by law. Proper notice of the public hearing for the consideration of the adoption of the Final Budgets was published in the Salt Lake Tribune, Deseret News, the Utah Public Notice website, the Murray City website and posted at City Hall. Said public hearing was held on June 4, 2024, and another public hearing was held August 13, 2024 and public comment was received. After considering input from the public, the Murray City Municipal Council wants to adopt its Final Budgets.

The Murray City Municipal Council adopts, as revenue to the General Fund, a tax levy that exceeds the certified tax rate. By increasing the tax levy above the certified tax rate under Utah law, the City was required to comply with the truth-in-taxation requirements before its Library and General Fund budgets become final. Therefore, the City adopts its budgets which have been subject to compliance with the Truth-in-Taxation laws, UTAH CODE ANN. Title 59, Chapter 2.

BE IT ENACTED by the Murray City Municipal Council as follows:

Section 1. Purpose.

The purpose of this Ordinance is to adopt the Final Fiscal Year 2024-2025 Budgets of the City including the Library Fund budget, subject to compliance with requirements of UTAH CODE ANN. Title 59, Chapter 2.

Section 2. Enactment.

The Final Budgets for Fiscal Year 2024-2025 are hereby adopted and shall consist of the following:

Section 3. Special Revenue Funds.

The Final Budgets of the Library, Redevelopment Agency, and Municipal Building Authority are as follows:

Municipal Building Authority	\$ 22,369,959

The Redevelopment Agency Board and Municipal Building Authority have, in separate action, passed and ratified the Redevelopment Agency Final Budget and the Municipal Building Authority Final Budget, respectively.

Section 4. Compliance with UTAH CODE ANN. Title 59, Chapter 2.

Since the Final Budgets include an increase in revenue from a tax levy that exceeds the certified tax rate, the budgets for the Library and General Funds adopted herein are subject to compliance with the requirements of UTAH CODE ANN. Title 59, Chapter 2.

Section 5. Adjustments.

- A. The Budgets are subject to adjustments, if any, that need to be made when the Murray City Municipal Council adopts the tax levies based on the certified tax rate.
- B. The Library and General Fund Budgets are subject to adjustments, if any, that need to be made following compliance with UTAH CODE ANN. Title 59, Chapter 2.
- C. The Director of Finance is hereby authorized to adjust the budgets to reflect the actual certified tax levies provided to the City.

Section 6. Transfer of Unencumbered or Unexpended Appropriated Funds.

The Director of Finance is authorized to make such transfer of any unencumbered or unexpended appropriated funds pertaining to the 2024-2025 Fiscal Year budget at the close of the 2024-2025 fiscal year in conformity with provision of UTAH CODE ANN. Section 10-6-124, as amended.

Section 7. Effective Date.

This Ordinance shall take effect on July 1, 2024.


