JOINT RESOLUTION NO. R24-54

**JOINT RESOLUTION OF THE MURRAY CITY MUNICIPAL COUNCIL AND MAYOR
DESIGNATING THE WEEK OF OCTOBER 6 THROUGH OCTOBER 12, 2024, AS
FIRE PREVENTION WEEK.**

WHEREAS, Murray City is committed to ensuring the safety and security of all those living in and visiting our city and state; and

WHEREAS fire is a serious public safety concern both locally and nationally, and homes are the locations where people are at greatest risk from fire; and home fires killed more than 2,700 people in the United States in 2022, according to the National Fire Protection Association® (NFPA®), and fire departments in the United States responded to 360,000 home fires; and roughly three out of five fire deaths happen in homes with either no smoke alarms or with no working smoke alarms.

WHEREAS, working smoke alarms cut the risk of dying in reported home fires almost in half; and, smoke alarms sense smoke well before you can, alerting you to danger in the event of fire in which you may have as little as 2 minutes to escape safely; and residents should install smoke alarms in every sleeping room, outside each separate sleeping area, and on every level of the home.

WHEREAS, residents will make sure their smoke alarms meet the needs of all their family members, including those with sensory or physical disabilities; and residents should test smoke alarms at least once a month and, residents who have planned and practiced a home fire escape plan are more prepared and will therefore be more likely to survive a fire; and

WHEREAS, Murray City first responders are dedicated to reducing the occurrence of home fires and home fire injuries through prevention and protection education; and residents are responsive to public education measures and are able to take personal steps to increase their safety from fire, especially in their homes; and

WHEREAS, the 2024 Fire Prevention Week theme, “Smoke alarms: Make them work for you.” serves to remind us the importance of having working smoke alarms in the home.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Murray City Municipal Council that the Mayor and Council do hereby

1. proclaim October 6–12, 2024, as Fire Prevention Week throughout Murray City;
2. urge all residents to make sure their homes have working smoke alarms and
3. urge all residents to support the public safety activities and efforts of Murray City fire and emergency services.

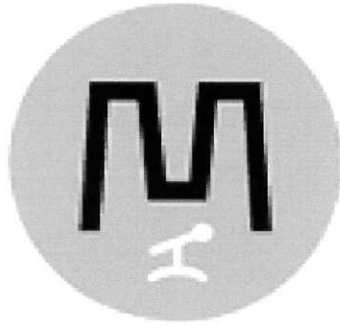
