Notice is hereby given that the Murray City Municipal Council has a Council seat vacancy for Council District 3 as of December 31, 2024, and will be accepting applications from interested individuals to fill the vacancy. This is an interim appointment that will be followed by an election to fill a two-year term. (See Utah Code Ann. §20A-1-510(2).) The appointment will last until a newly elected Council Member for Council District 3 is sworn in pursuant to state law in January 2026.

To be considered for the appointment as an interim Murray City Municipal Council member for Council District 3, applications must be received by Jennifer Kennedy, City Council Executive Director, at the Murray City Hall Council office, 10 East 4800 South, Room 290, Murray, Utah, **no later than 5:00 pm on Thursday, January 16, 2025**. Application forms are available at the Murray City Council office and the Murray City website ([www.murray.utah.gov](http://www.murray.utah.gov)).

The City Council will hold an open and public meeting on **January 21, 2025, at 5:00 p.m.** in the City Council Chambers, Murray City Hall, 10 East 4800 South, Murray, Utah for purposes of interviewing qualified applicants. After conducting the interviews, the City Council will vote to select an interim City Council member for Council District 3. After the selection, the Council will appoint and have sworn in the interim Municipal Council member for Council District 3.

An applicant must be a registered voter, a resident of Murray City for at least 12 consecutive months before the date of appointment, and a resident of District 3. (Additionally, Utah law prohibits a mentally incompetent individual, an individual convicted of a felony, or an individual convicted of treason or a crime against the elective franchise from holding office until the right to hold elective office is restored.)







## Clark's Letter of Intent Regarding District 3

Esteemed Council, I would love to represent District 3. I love our city, I love my district and as it turns out, I love municipal civics but this wasn't always the case. I was interested in the direction of Downtown Murray as I live close by and was supporting a candidate for Mayor who had a similar vision for downtown possibilities. This candidate had to drop out due to health reasons and those of us who supported him were discussing who else might be a good candidate. Someone suggested I run, I was naive enough to think, how hard could it be? :)

Hard, it could be very hard but also, very rewarding! I loved canvassing and getting to know the wonderful citizens of Murray. I loved discussing what they enjoyed about Murray and what they would like to see improved. I loved learning from my fellow Murrayites. We have a wealth of knowledge in our great city! I also loved learning about how the city works. I'm still learning. I love learning from our great city employees. We truly must have the best people working for Murray. I can't imagine it gets much better than this. The employees of Murray City have been gracious with their time and expertise. They have helped me see our fine city through new eyes. Over time my views on what is best for Murray have become more informed, more nuanced, more moderate in tone and approach if not in passion.

When my quixotic candidacy ended as you might expect, I found myself not wanting it to be over. I always thought Murray was great but I had fallen in love and was not about to let go. I had campaigned on abundant citizen engagement and communication. I made promises to do my best to help keep citizens informed and aware of what is happening in our community. I intended to keep that promise no matter what side of the Dais I was on.

I have done my best to stay informed by reading the packets and attending the meetings for PC, COW, RDA, and Council and asking staff or council members when I needed clarification. I have attempted to encapsulate the proposals that I believe the citizens would care about based on my interactions with them. I have not always captured issues entirely accurately, not for lack of effort. For this, I truly apologize. I have attempted to improve my communications as recently as this past year. I hope to continually do so, potentially with more communication directly with the council and certainly with appreciation for your patience and understanding.

I once again had the marvelous opportunity to run but this time to represent my own council district. I again loved the opportunity and was excited about the prospect to serve the citizens of District 3. I felt like I really had a chance this time. I believe I had received more votes for Mayor in District 3 than any candidate had previously received in our district for any race. As it turns out, the turnout was different. I had momentum and support but not a sufficient get-out-the-vote strategy. I worked hard but fell short. 984 to 1095, 111 votes short. I think a lot about what I could/should have done differently but ultimately, I believe that things happen for a reason.

I know there will be lots of great options for the council to fill this vacancy. As previously stated, we have a wealth of wisdom in our community. I know that whatever the council decides will be the right thing for Murray and District 3. I am asking for your vote but trust you will make the right decision and support you in the direction you feel is best. Either way, you know where I'll be on Tuesday nights :)
