Mayor Snarr introduced the 2007-2007 Miss Murray, Heidi Searle. The Mayor stated that Ms. Searle grew up playing sports with Murray Recreation and Murray Max Soccer; She played 4 years of Varsity soccer with Murray High School, and was awarded *Most Inspirational Player*. She also played soccer for Salt Lake Community College. Ms. Searle is a *Dating Dangers* ambassador for Ms. Huntsman's "Power In You" program. She has won an award for her song "He Loves Me Not," a 2007 teen dating violence song writing contest, and has won 3d place in KUTV's Utah Talent competition.

Mayor Snarr continued by saying that Ms. Searle is currently enrolled at Salt Lake Community College, works part-time at the Adoption Exchange Center, her passion coming from her nine adopted siblings. Heidi is also a part-time nanny. She hopes, one day, to become a licensed dental hygienist.

The Mayor also noted that Heidi will be singing at the Heart Gallery opening on November 01, 2007. The Heart Gallery is a project working with children waiting in Foster Care for adoption; the children meet with photographers and their portraits become the Gallery, promoting awareness and education.

Ms. Searle thanked the Mayor stated that her platform is adoption, and had passed out flyers and invitations to the gallery. The photographers who take the pictures of the children donate their work to the gallery. She stated that currently in Murray alone, there are 92 children in Foster Care.

Ms. Searle presented a slide show of the children, and sang for the Council and citizens.
