**Business Item: Consider a resolution amending the budget for the MBA (Municipal Building Authority) of Murray City for FY (Fiscal Year) 2022-2023:**

Ms. Moore explained the proposed resolution appropriates money from the MBA reserves fund to the building and construction account for the New City Hall Construction Project. In FY 2022, \$10,657,000 was budgeted with an understanding that construction would not be completed by July 1, 2022. Therefore, a transfer of \$15,301,855 occurred in June of 2022 as part of the MBA adopting the new FY 2022-2023 MBA budget. The proposed resolution allocates the remaining amount needed of \$4,838,506 to complete the project.

Ms. Dominguez opened the public hearing. There were no public comments, so the public hearing was closed. Ms. Dominguez called for a motion to approve the resolution. Ms. Turner moved to approve. Mr. Hrechkosy seconded the motion. All in favor 4-0. The motion passed.
