### Getting there and Getting Around

1. Entrances, Parking & Pathways
  - a. The Amphitheater is tucked between the cottonwoods and the creek in Murray Park.
  - b. There are two parking lots with paved sidewalk access to the amphitheater. The first can be accessed at 495 E 5300 South (east end of Murray Park). The second parking lot is located in front of the Murray Parks & Recreation Office inside Murray Park.
  - c. Additional ADA parking is located on the west side of the Amphitheater and can be accessed by a driveway, south of the Murray Parks & Recreation Office.
2. Seating
  - a. Seating includes aluminum benches with backs and spots for wheelchair access and companion seating. It is recommended to bring your own cushion or blanket.
3. Restrooms
  - a. Restrooms are available on the south side of the amphitheater inside the gates. There are additional restrooms on the east side outside the gate, next to the concession window.
4. Food and Drinks
  - a. Amphitheater policy prohibits smoking, alcoholic beverages, and large coolers.
  - b. Outside food and non-alcoholic drinks are permitted inside the gates.
5. Inclement Weather
  - a. For inclement weather information, phone (801) 264-2638 approximately 60 minutes before show time. Single night shows may be moved to an alternate location.
  - b. In the event of a rainout cancellation, individual tickets may be exchanged for a future event of equal or lesser value. No refunds.
6. Service Animals
  - a. Service animals that are trained to do work or perform tasks for a person with a disability are welcomed at the amphitheater. Non-service animals, or pets whose function is to provide emotional support and comfort are not permitted.

- b. In order to bring a service animal into the amphitheater, the animal must be harnessed, leashed or tethered, unless the device interferes with the service animal's work or the individual's disability prevents the use of the harness.
- 7. Video Recording
  - a. Video recordings are strictly prohibited without permission from Murray City.

**Accommodations Request Policies**

- 1. The Parks & Recreation Office will use its best efforts to accommodate where needed. Special accommodations for the hearing or visually impaired will be made upon request directed to Lori Edmunds at (801) 264-2620 or [ledmunds@murray.utah.gov](mailto:ledmunds@murray.utah.gov). Please allow our staff to review the request at least three working days prior to the event.
- 2. When we are not able to meet accommodation requests, we will communicate that deficiency honestly and respectfully. We will also make note of each request for future accessibility planning. We respect the privacy of our guests and only share necessary information with staff as needed.
